ELIGIBILITY:

All applications will be subject to Committee approval before acceptance.

The following items must accompany your application to be considered complete and ready for Committee review **ALL ITEMS LISTED BELOW MUST BE TURNED IN EVEN FOR RETURNING VENDORS “REFER TO PRIOR APPLICATION” IS NOT AN ACCEPTABLE RESPONSE FOR**

OMITTING COMPONENTS:

- List of Products
- Copy of Valid Tax ID/ Tax Exemption/ EIN Form (whichever is appropriate for you)
- Picture of your Products on display at booth
- Completed Application** with all other components

ADDITIONAL:

Vendors with proof of insurance will be considered first by the committee during approval process.

AFTER SELECTION AND ACCEPTANCE!

All accepted vendors will be required to purchase an additional Village of Patchogue Permit (see below for more details) that will need to be either prominently displayed or easily accessible to present on every event day.

Rain Date: August 15, 2024 - no refunds for inclement weather.

Set Up/Breakdown: Starts as early 3:30 PM SHARP Vendors will be informed of their specific time window. All vehicles MUST BE removed from the street by 4:45 p.m. or be towed. **Arrive no later than 4:30 p.m. NO EXCEPTIONS.** Any vendor arriving late will be told that to participate in that evening they must park their vehicle and carry their setup to their designated spot. Vehicles will not be permitted back on site before 9:00 p.m., and must be off the street by 10:00 p.m. No selling after 9:00 p.m.

General Info: Vendors are responsible for keeping their displays clean. All trash and boxes are to be taken with you. No refuse to be left on the street, the curb or in receptacles on the sidewalk. No electric service will be provided. Battery operated lanterns are recommended. Generators must be kept at low decibels (if we hear it, smell it, or get complaints from your neighbors, you will be asked to shut it down and not bring it back to remaining Alive After Five® events this season). No Animals other than designated service dogs will be permitted as part of your booth set up.

Any merchandise deemed by the committee objectionable and not in keeping with our family atmosphere must be removed. Nuisance items such as silly string, spray paint, toy guns, knives, fireworks of any kind, etc. are prohibited from the event and cannot be sold by vendors. **Vendors are not permitted to hand out free water or drinks.** Vendors are also not permitted for any reason to give or sell any portion of their designated spot(s) to other vendors. Trading of spots, without consent of all vendors involved and Committee approval is prohibited. The use of plastic bags and straws as well as, Styrofoam containers by merchants of any type **has been banned** within the village boundaries. Any vendor caught using them may be fined by the village with the possibility of ejection from the event without refund if caught repeating this offense. Any non-compliance with the above stated rules or state and local regulations will result in expulsion from the event without refund or further recourse.

Judgment by the Committee is final.

Application and all additionally requested paperwork **MUS BE RECEIVED BY THE PATCHOGUE CHAMBER OFFICE BY: 5:00 PM Thursday, May 2, 2024** in order to be considered eligible for Committee review. **DO NOT SEND PAYMENTS WITH APPLICATION. PAYMENT WILL BE COLLECTED UPON APPROVAL OF APPLICATION.** The application review process will begin immediately after the May 2 deadline. All vendors will be contacted with results status. Approved vendor payment must be received in full **by: Friday, May 23, 2024** in order to receive spot #s and event passes.

Due to Suffolk County Department of Health policy changes, we will not be able to update and add vendors that sell prepackaged foods or do samples that must comply with DoH regulations/require a health permit after we submit our permit to them.

All Vendors will also be required to purchase additionally a Patchogue Village Vendor Permit to be allowed to participate in chamber events.

All vendors selected for Alive After Five® will be sent a link to fill out this online Village Vendor Application.
