- 2. Copy of your resale sales tax certificate
- 3. Certificate of Liability Insurance minimum \$1million coverage naming: The Greater Patchogue Chamber of Commerce Inc. & The Greater Patchogue Foundation as additionally Insured, 15 North Ocean Ave, Patchogue, NY 11772.
- 4. Copy of your approved annual or temporary DOH Permit (required upon acceptance into festival)
- 5. A picture of your Food truck/trailer/stick stand setup
- 6. If you use an external generator, please include: make, model, gas or electric, and noise level information
- 7. <u>A copy of your APPOVED Village "Application for Operation of a Vendor Truck" from the Village of Patchogue Fire Inspector.</u>

#### **AFTER SELECTION AND ACCEPTANCE!**

All vendors will be required to purchase an additional Village of Patchogue Permit (see below for more details) that will need to be either prominently displayed or easily accessible to present on every event day.

Department of Health Permit – Obtain your DOH permit immediately and mail an approved copy to us by **Thursday**, **June 14**, **2024**.

Application Review process will begin immediately after May 4th. All vendors will be contacted with the results of selection. Approved vendor payment must be received in full by Friday May 23, 2024, in order to receive spot #s and event pass 2024.

<u>IF ACCEPTED</u>, set up is from 3:30PM to 4:00 PM sharp <u>Failure to arrive for setup during the</u> <u>allotted time may result in your inability to participate in that evening's event. No Refund will be given in this situation.</u>

## Food Vendor Application

No selling after 8:45 pm. All vehicles must be off the street by 10:00PM. No Exceptions. If you do not comply, you will be asked not to return and lose the fee already paid!!!

Vendors are responsible for keeping their area clean. All trash & Boxes are to be taken with you. **No refuse** is to be left on the street, on the curb, or in receptacles on the sidewalk. No electric service will be provided. Generators most comply with specs similar to that of a Honda eu2000i electric generator. Prices must be posted large enough so customers online can see them clearly.

No refunds will be given due to inclement weather or dissatisfaction of spot placement.

The use of plastic bags/straws and Styrofoam containers by merchants of any type <u>has been banned</u> within the village boundaries. Any vendor caught using them may be fined by the village with the possibility of ejection from the event without refund if caught repeating this offense.

#### **ADDITONAL REGISTRATION & FEES:**

All Food Vendors are required to contact the Patchogue Fire inspector to determine if you need to be inspected and approved or are exempt. If required to be inspected, there is no additional charge for this inspection. All Vendors must attach a copy of the inspection form stating either exempt or that you have passed inspection. Failure to include this in your application prior to the deadline will result in immediate disqualification of your application from moving forward for selection.

All Vendors will also be required to purchase additionally a Patchogue Village Vendor Permit to be allowed to participate in Alive After Five®.

All vendors selected for Alive After Five® will be sent a link to fill out this online Village vendor application.

You will not be permitted to take part in Alive after Five without purchasing this permit. Purchase of a village vendor permit prior to selection review will not guarantee your acceptance into the event and will not be refunded if a vendor is not selected to take part in the 2024 event.

Please return this application with All Additionally requested paperwork by May 2, 2024. – Balance cutoff due upon acceptance into the event. Please enclose your Certificate of Insurance as specified on the information sheet as well.

\*\*Suffolk County Department of health approved permits must be submitted to us by June 14, 2024. \*\*

<u>Due to Suffolk County Department of Health policy changes, we will not be able to update and add food vendors after submitting our permit paperwork for the event to them. As such, no food vendor applications after the deadline will be accepted.</u>
